- Kendall Vaught was elected as our new District M CTA Board member. Kendall is filling the seat vacated by our former Board member, Jim Rogers.
- CORE standards are coming sooner than expected. State wants CST tests to be taken on computers and want longer testing periods - concerns regarding money and proper adopted curriculum.
- Phone banks were held for Ohio elections reminding voters to vote "No" on Prop 2 which proposes an end to collective bargaining.
- US Department of Education wants to tie student achievement not only to teachers but on the teaching program (college and professors) that trained them.
